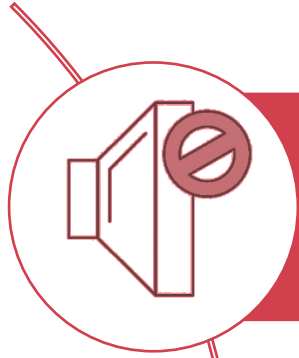

Acknowledging First Nations

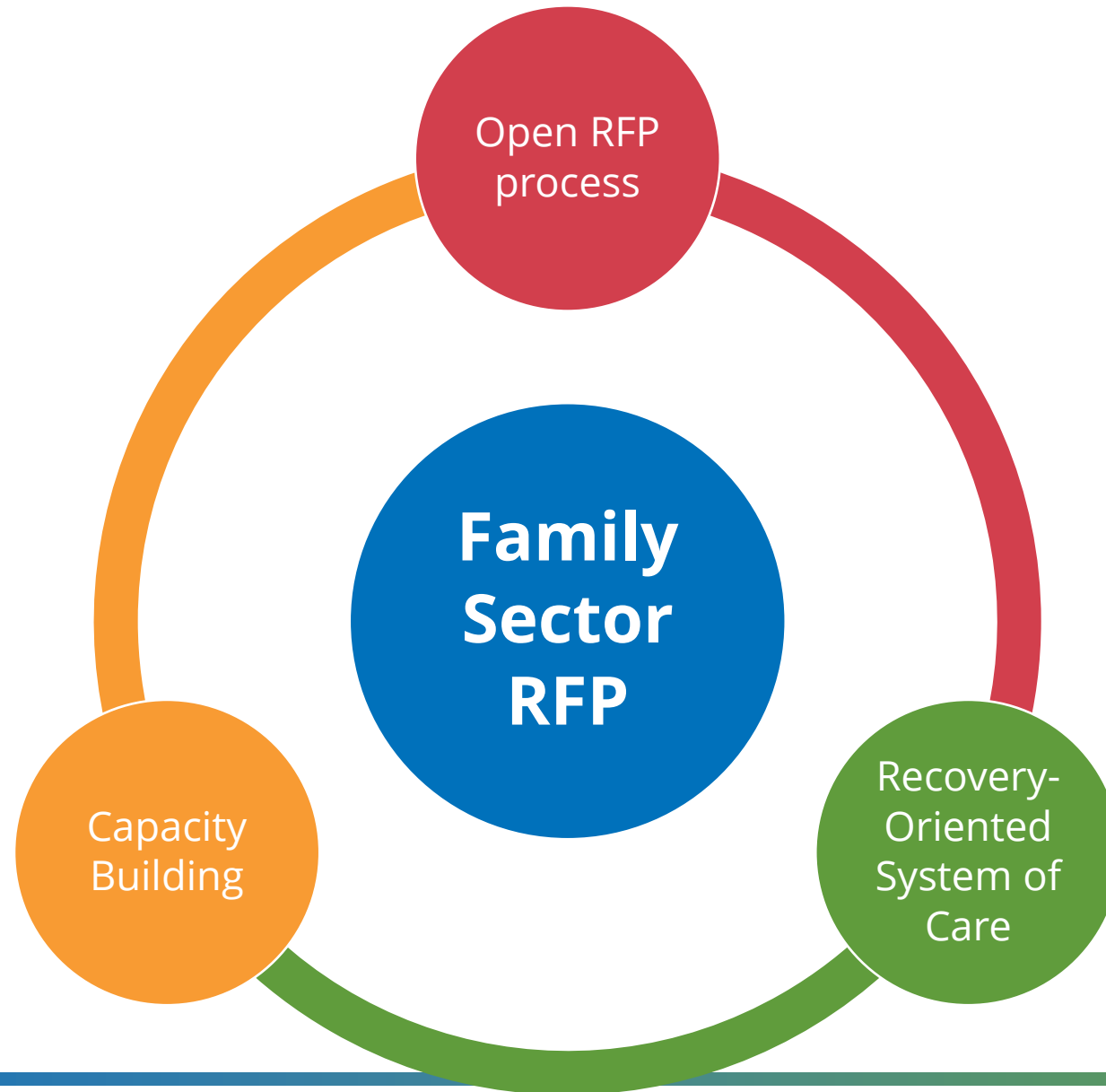

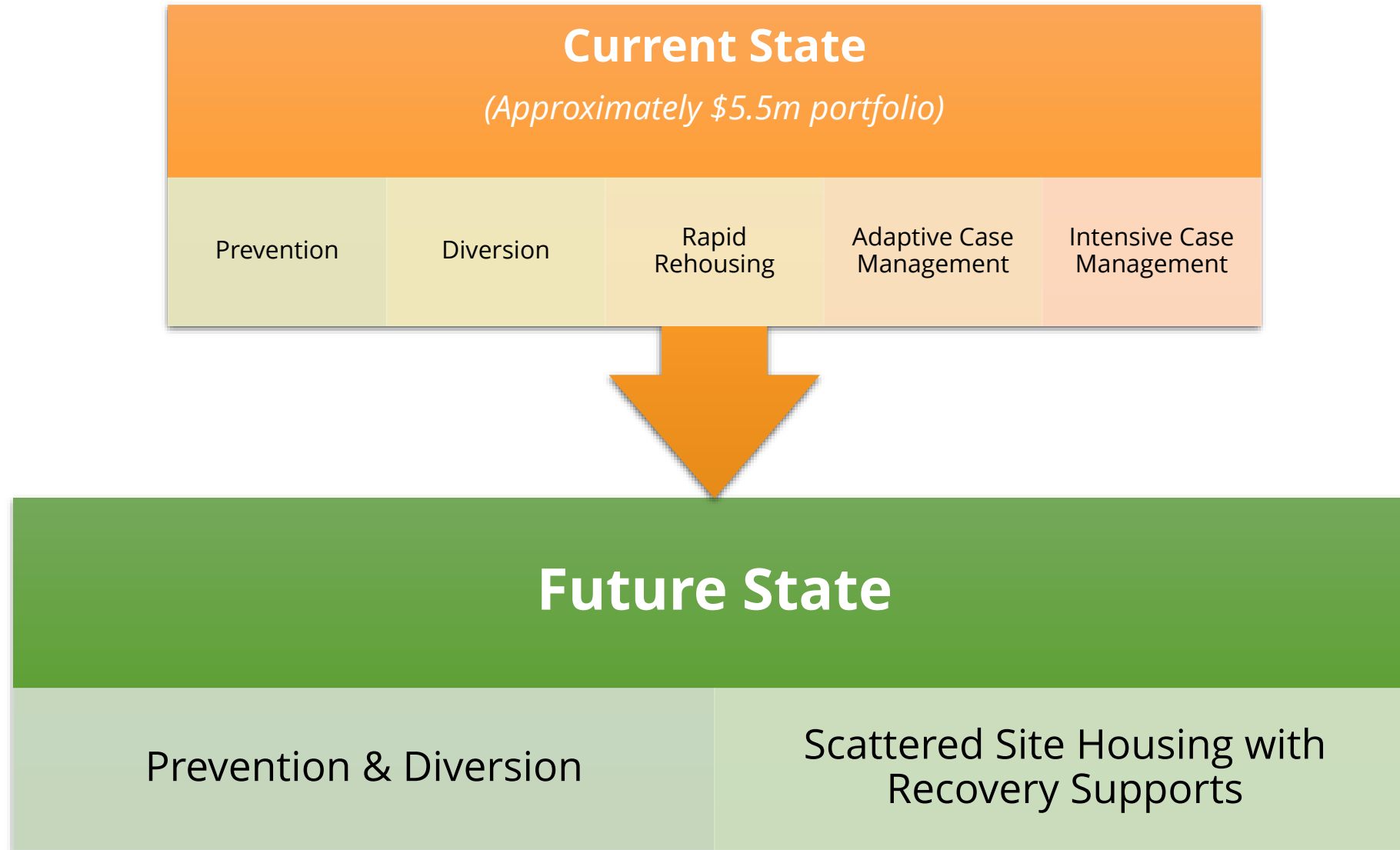

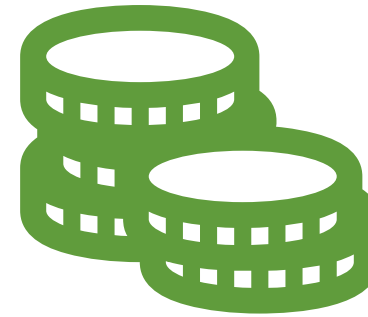
